Motion by Commissioner Kollhoff, seconded by Commissioner Witt to approve a bid from Valor Automotive and KA-Comm for the purchase of a 2022 Ford Explorer Interceptor and a 2022 Ford F-150 Police Response Vehicle and the installation of police equipment in both vehicles in the total amount of \$65,854.06. 11. Consider approval of a bid from J & K Contracting, L.C. for the 2022 Waterline Construction Project in the amount of \$85,746.10.

Motion by Commissioner Witt, seconded by Commissioner Rein to approve a bid from J & K Contracting, L.C. for the completion of the 2022 Waterline Construction Project in the amount of \$85,746.10 and the purchase of materials for the project with a total project cost not to exceed \$162,000.00. Roll call vote: Rein YES, Witt YES, Miller YES, Kollhoff YES, Marshall YES. Motion carried unanimously 5-0.

12. City Manager reports

Construction on the Police Department remodel continues. We had a status meeting with the architect and general contractor on January 4th to review progress, walk through the project and discuss some change orders.

Our new police officer, Amanda Wilson started KLETC on January 3rd. She should graduate in April.

The new School Resource Officer, Kris Kobiskie started his on January 4th. Kris is new to this role but not a new officer to the Abilene Police Department.

Construction on Well #23 continues. We are currently waiting on electrical parts to continue.

The Fire Department has filled their two open positions. Starting the first of the year they have moved to 3 person shifts. With a minimum of 2 personnel required per shift, this should help with overtime and other coverage issues.

The Public Works Department did a phenomenal job with the snow removal process during the two separate snow events last week. They treat and clear all emergency snow routes, identified secondary routes, the downtown area, and a route to the schools. A total of 51.71 lane miles are treated and cleared during storm events.

January 26th is local government day; this is a good time to meet with our state representatives. The one in April is a good one for new commissioners as it covers the Kansas Open Meetings Act as well as other topics.

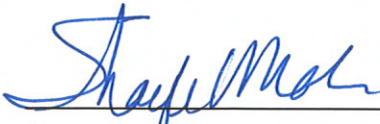
13. Consideration of a motion to adjourn the January 10, 2022, City Commission meeting.
