Reports

13. City Manager reports

The Police Department remodel continues moving forward. We had some issues with the internet services but those have been resolved.

Last fall the Police Chief and I sat down to review the current pay of our police officers. The area of concern was compensation for years of service. The Dickinson County Sheriff's Office (DKSO) is one of the organizations we know we need to stay competitive with and Chief knew the County Commissioners had approved a significant adjustment to the DKSO pay schedule starting in 2022. Chief and I felt strongly that we needed to adjust the pay of our police officers to stay relevant with the DKSO. Earlier this month we met with the Finance Director to determine what, if any, adjustments we could make within the budget. After Marcus ran the numbers, we will be able to increase each officer's pay to better reflect their years of service and position in comparison to the DKSO. All adjustments will be made within the applicable range on the pay schedule. These pay adjustments will take affect February 1st.

For the 2023 budget one new expenditure request was going to be to fund the administrative assistant position for City Hall, a position that was previously funded. This position would assist planning and zoning, finance, community development, the city clerk, and the front desk. During the review of the police pay increases, Marcus discovered that we already have the position funded for 2022. Therefore, we will be advertising, interviewing, and hiring for an administrative assistant.

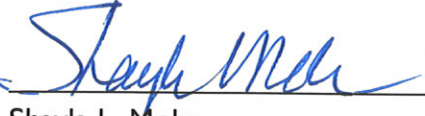
