Kellee and I are working to find a solution to the leaking roof at the Recreation Center.

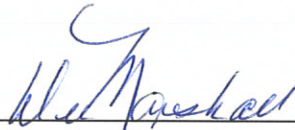

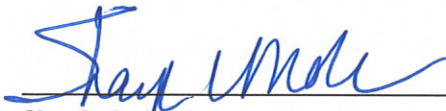
11. Consideration of a motion to adjourn the May 23, 2022, City Commission meeting.
