1. Call to Order the June 22, 2026, City Commission Meeting

2. Roll Call: Mayor Rein, Commissioners Taylor, Kollhoff, Lytle and Meysenburg

4. Approval of the Agenda for the June 22, 2026, City Commission Meeting

Motion by Commissioner Kollhoff, seconded by Commissioner Taylor, to approve the agenda with the removal of item 7a, regarding the sport's complex agreement. Roll call vote: Taylor YES, Kollhoff YES, Lytle YES, Meysenburg YES, Rein YES. The motion carried 5-0.

5. Consent Agenda for the June 22, 2026, City Commission Meeting

Consent Agenda items are considered routine business items. The consent agenda can be acted upon by one motion unless a majority of the City Commission votes to remove an item for discussion and separate action.

Motion by Commissioner Taylor, seconded by Commissioner Lytle, to approve the Consent Agenda as presented. Roll call vote: Kollhoff YES, Lytle YES, Meysenburg YES, Taylor YES, Rein YES. The motion carried 5-0.

6. Public Comments and Communications

- a. Public Forum: Persons who wish to address the City Commission regarding items outside the agenda may do so when called upon by the Mayor. Speakers will be allowed a three-minute time limit.

Julie Roller Weeks, Abilene Convention and Visitors Bureau Director, spoke regarding 2026 being the 150th Anniversary of Wild Bill Hickok's death. Chisholm Trail Days will take place on Saturday, August 15, 2026, and will include the longhorn parade and Wild Bill Hickok reenactments at Old Abilene Town. The dedication of the official Wild Bill Hickok monument will take place Sunday, August 16, 2026, at 1 pm at Old Abilene Town. This special project was made possible through the generosity of the family of the late Nebraska sculptor David R. Young, who gifted the sculpture to the City of Abilene.

Gary Boyd, 301 NW 17th, spoke regarding major flooding in his area. There is nothing he can do to stop the problem. He would appreciate any help the city can give to remedy the problem.

Andy Hess, 303 NW 17th, also spoke regarding the flooding in his area. It is the worst between his property and Gary Boyd's. The last time it flooded, the water came very close to the houses' windows.

Public Works Director Anderson explained to the Commission where the floodwater comes from.

Jeff Hindman, 304 NW 17th, spoke regarding the floodwater. It has happened 2–3 times in the last month and a few times in the last five years. There is too much water and inadequate drainage. He asked the commission to do what they can to remedy the issue.

Judy Boyd, 301 NW 17th, urged the commission to review the emailed videos and have the area engineered to determine the cause of the problem. As property owners, they have done everything in their power. Homeowner's insurance does not cover flooding.

- c. Consider Approval of the Low Bid for Replacement Fire Hydrants

Motion by Commissioner Taylor, seconded by Commissioner Lytle, to approve the low bid from Municipal Supply, Inc. of Wichita for the purchase of fire hydrants in the amount of \$41,484.90. Roll call vote: Taylor YES, Kollhoff YES, Lytle YES, Meysenburg YES, Rein YES. The motion carried 5-0.

d. 2027 Budget Discussion — Enterprise Funds

Finance Director Briand presented the proposed 2027 budget for the Enterprise Funds.

The Commission directed staff to prepare a Request for Proposal for the City's operating checking account.

We have received approval for \$400,000 for the Wastewater Treatment Plant but have not received any information regarding the Water Treatment Plant application. He will contact KDHE and Olsson for an update.

- a. Consider a motion to adjourn the June 22, 2026, City Commission Meeting.

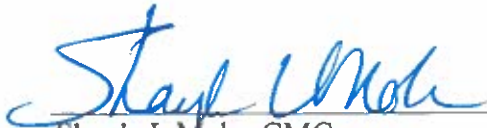
The City Commission Study Session will be held at City Hall, 419 N. Broadway Street, following this meeting.
